ANNUAL PARISH MEETING MINUTES

The Chairman confirmed any Stakeholder reports provided are available on the Council web site and commended them to anyone requiring more information.

APM.01 To note the ex-Chairman's Annual Report. Minute- the Chairman expressed her thanks to Councillors, past & present, for their support throughout a most tumultuous year. She was proud that the Council had acquitted itself in an exemplary manner under extremely challenging circumstances.

APM.02 To note the RFO's Annual Report. Minute- the RFO summarized his report advising Council reserves had been reviewed and that they had increased marginally over the year as many projects had been necessarily curtailed by HMG restrictions.

APM.03 To note a report from Buckinghamshire County Council. Minute- BC Cllr Macpherson summarized the County Annual Report, expressing her pride in how well the Council had continued to function during unification of the various District Councils and all in the midst of a world pandemic.

APM.04 To note a report by Thames Valley Police community policing team. Minute- PC Tom Chalk had submitted a report on the volume & types of crime in the parish.

APM.05 To note a report from the Village Hall Charity. Minute- a report had been published summarizing the the role of the Hall as a community focal point.
