

Section 3 – External Auditor’s Report and Certificate 2024/25

In respect of **Grendon Underwood Parish Council – BU0087**

1 Respective responsibilities of the auditor and the authority

Our responsibility as auditors to complete a **limited assurance review** is set out by the National Audit Office (NAO). A limited assurance review is **not a full statutory audit**, it does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and hence it **does not** provide the same level of assurance that such an audit would. The UK Government has determined that a lower level of assurance than that provided by a full statutory audit is appropriate for those local public bodies with the lowest levels of spending.

Under a limited assurance review, the auditor is responsible for reviewing Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with NAO Auditor Guidance Note 02 (AGN 02) as issued by the NAO on behalf of the Comptroller and Auditor General. This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with *Proper Practices* which:

- summarises the accounting records for the year ended 31 March 2025; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

2 External auditor’s limited assurance opinion 2024/25

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review. Please ensure that amendments are corrected in the prior year comparatives when completing next year’s AGAR.:

- Transfers between bank accounts should have been excluded from receipts and payments in Section 2. The smaller authority prepares its accounts on a receipts and payments basis and therefore Section 2, Box 7 should equal Section 2, Box 8. The difference is due to transfers made into a higher rate deposit account. The figures in Section 2, Boxes 2 to 7 should be restated to reverse the transactions associated with the transfers into the deposit account so that they cast to a Box 7 total of £51,179 which will agree to Box 8 and the bank reconciliation submitted in support of Box 8. Any interest received during the year should be recognised in Section 2, Box 3 as income.
